I, The Client, fully understand that:

- The results of the coaching sessions are solely dependent upon me following the instructions and tasking that the Coach provides me during any and all of the coaching process; and that the onus is entirely upon me on completing whatever tasks the Coach provides me to complete/conduct. - I acknowledge that I am psychologically sound and know of no reason (medical, psychological or otherwise) why I should not undertake coaching
- I am not taking any prescribed medication that could adversely impact on the coaching process, nor am I seeing a counsellor or therapist. I agree that I will inform the Coach if this changes during the coaching relationship.
- I will give the Coach at least 72 hours' notice of cancellation, otherwise I will pay for the session cancelled. I understand that the Coach will provide me a free session if he does not give me 72 hours' notice of cancellation. (Genuine medical emergencies excepted for either party)
